

SOUTH PRONG HUNT CLUB RULES

NUMBER ONE RULE: ALL COMPLAINTS AND QUESTIONS GO TO THE PRESIDENT (DOUG MOORE) BY E-MAIL:

mmdairy@bellsouth.net 2. NO USE OF DRUGS AT ANYTIME. NO ALCOHOLIC BEVERAGES WHILE HUNTING.

3. FOLLOW ALL FLORIDA WILDLIFE SERVICE GAME LAWS AND ALL CLUB RULES. 4. KEEP ALL GATES LOCKED AT ALL TIMES. DO NOT DRIVE AROUND GATES OR ENTER PROPERTY THROUGH ANY OTHER MEANS EXCEPT THROUGH DESIGNATED GATES, THIS INCLUDES ATV VEHICLES.

5. ALL HUNTERS MUST SIGN IN AND OUT AT BEGINNING AND END OF HUNT, IN THE APPROPRIATE AREAS.

A: North area; Bumpy Rd. sign in station. B: DeMay (north of John Mann Rd.); camp trailer.

6. ALL HARVESTED GAME MUST BE RECORDED.

7. NO TRASHING THE LAND.

8. TURKEYS CAN BE HUNTED IN ACCORDANCE WITH THE FWC REGULATIONS WITH THE EXCEPTION THAT THEY CANNOT BE HUNTED WITH RIFLES ON HANDGUNS.

9. NO GUEST HUNTING ALLOWED. EXCEPTIONS: CHILDREN, WIFE OR GIRLFRIEND CAN SIT STAND WITH MEMBER AND HARVEST GAME. THE GAME WILL BE COUNTED AS PART OF MEMBERS QUOTA.

10. NO ROAD HUNTING OR NIGHT SHINING.

11. DURING SEASON, 4-WHEELERS CAN BE USED FOR HUNTING TRANSPORTATION, NO JOY RIDING DURING HUNTING. 12. LEASE REQUIRES THAT ALL STANDS BE PORTABLE. NO NAILS OR

SPIKES IN TREES. NO STANDS ON MAIN ROADS.

13. NO STANDS WITHIN 50 YARDS OF PROPERTY LINE.

14. SCOUTING DURING SEASON CAN ONLY BE DONE BETWEEN 11 A.M. AND 3 P.M.

15. ALL MEMBERS WILL BE REQUIRED TO SIGN LIABILITY RELEASES FOR SOUTH PRONG HUNT CLUB, RAYONIER AND PLUM CREEK.

16. FEEDERS: MUST BE MAINTAINED UNDER FWC REGULATIONS.

17. ANY WOUNDED DEER (BLOOD FOUND) COUNTS AS A KILL, THEREFORE PART OF YOUR QUOTA WEATHER RECOVERED OR NOT. 18. THERE WILL BE TWO SCHEDULED WORKDAYS; AT LEAST ONE IS MANDATORY (OR PAY \$50.00 FEE).

19. EACH MEMBER WILL BE ALLOWED TWO PERMANENT STANDS. THESE CAN ONLY BE HUNTED BY THE MEMBER OR WITH THIER PERMISSION. THE STANDS MUST BE AT LEAST 200 YARDS AWAY FROM AN CLUB OR OTHER MEMBERS STAND. THEY MUST BE MARKED ON THE CLUB MAP. CLUB STANDS CAN BE HUNTED BY ANY MEMBER ON A FIRST COME FIRST SERVE BASIS. 20. IT IS EVERY MEMBER'S RESPONSIBILITY TO FOLLOW RULES AND REPORT VIOLATIONS OF RULES BY OTHER MEMBERS.

THE LAST WORD IS ALWAYS THE PRESIDENT. HE HAS THE POWER TO CHANGE RULES AT ANYTIME. IF HE THINKS IT'S IN THE BEST INTEREST OF THE CLUB, CAN ASK A MEMBER TO LEAVE WITHOUT REFUNDING MEMBERSHIP DUES.

SECTION NO. 1 PLUM CREEK SECTION NO. 2 RAYONIER NORTH
(north of John Mann Rd)

APPROVED CAMP DEER

- BUCKS MUST BE 3 POINTS ON ONE SIDE (A POINT IS DEFINED

AS BEING AT LEAST 1” IN LENGTH).

- NO MORE THAN 2 DOES CAN BE HARVESTED BY ANY MEANS. IT CAN BE BOW, ANTER-LESS SEASON OR WITH DOE TAG
- ONE DOE TAG WILL BE ISSUED TO EACH MEMBER UPON PAYING CAMP FEES. (DOE TAG DOES NOT INCREASE LIMIT ON DOES). **TAG CAN ONLY BE USED BY THE MEMBER WHO IS ISSUED THE TAG.**
- NO DOES ARE TO BE TAKEN AFTER THE FIRST SUNDAY IN DECEMBER.
- NO YEARLING BUCKS ARE TO BE HARVESTED. ANY MEMBER HARVESTING WRONG DEER WILL FORFIT THEIR DOE TAG AND PAY A \$200 FINE BEFORE CONTINUING TO HUNT. KILLING OF SECOND WRONG DEER WILL VOID MEMBERSHIP IN CLUB WITHOUT ANY REFUND OF DUES.

OTHER GAME

- HOGS AND PREDATOR HUNTING ALLOWED ALL YEAR.
- SMALL GAME MAY BE HUNTED AFTER DEER SEASON
